### Context and purpose of the job:

We are looking for an enthusiastic and skilled cook to work in a school environment specifically for vulnerable young people at our school in Norwich. You will be required to plan menus that provide delicious, well-balanced and nutritional meals, work to a budget, order/receive supplies, and maintain high standards of hygiene by adhering to company policies & procedures including HACCP & COSHH.

Experience of home baking would be especially desirable. It is essential to have the ability to interact with young people within the school building strong relationships quickly. The successful candidate should ideally possess a food hygiene certificate.

Here at Future Education all of our young people have SEMH (Social, Emotional and Mental Health) needs along with associated behavioural difficulties, and many have additional special educational needs such as speech, language and communication difficulties, autistic spectrum disorder (ASD) and attention deficit and hyperactive disorders (ADHD). Building strong positive relationships with our students is fundamental for all staff who work in our school in all roles. This post in particular, will involve much contact with students - an understanding and interest in our ethos and strategies for working with our students will be essential.

We are looking for a kind, compassionate and resilient person to fulfil a vital role in our school. The right personal qualities are especially important in working within our environment.

#### School Cook – Personal profile:

We are looking for a colleague who:

- Is a great cook and able to produce delicious, nutritious meals and snacks.
- Is able to plan menus within a budget and efficiently make and manage orders.
- Ideally has experience of working in a school environment working with SEND students and will understand the challenges facing our students.
- Is able to manage a kitchen area with frequent visits from students and staff
- Possesses a food hygiene certificate and follow the guidelines outlined in 'Food Safety for Better Business caterers Edition'
- Can work in an efficient and organised manner with a meticulous eye for detail
- Has a good literacy and numeracy skills, and possesses excellent communication skills.
- Is an excellent team player and able to accept and respond to advice given in order to provide the best possible experience for our students.
- Able to quickly make excellent relationships with both staff and students.
- Will be flexible, reliable and positive and looking to make a real difference in the lives of young people.



#### Job Description:

#### Key Deliverables:

The key deliverables outline the priority tasks and responsibilities of this post, against which the post-holder will be held to account.

<u>Legalities:</u> Know, understand and use the guidelines 'Food Safety for Better Business – caterers Edition'

<u>Food prep/serving:</u> plan, prepare and serve delicious meals to students lunch times, snacks at breaktime and breakfasts where needed

<u>Safety:</u> adhere to all health and safety, food hygiene, and risk management controls including awareness of allergens in the course of daily duties

<u>Recording:</u> maintain accurate records relating to the post, including but not limited to food temperature checks, cleaning records, chemical records, risk assessments, and orders.

<u>Stock control:</u> undertake stock review and control, ensuring that adequate food and resources are in place and available for use

<u>Cleaning:</u> clean and keep clean the school's kitchen, break and cleaning areas

## Detailed duties and responsibilities:

Plan menus that provide delicious, well-balanced and nutritional meals – one two course meal each day

Make a selection of sandwiches daily

Make breakfast for students who would like it and toast/snacks for breaktimes

Make and prepare packed lunches for school events, trips, early closing, examinations etc

Work to a budget,

Order and receive supplies,

Dynamic risk assessments to maintain safety in kitchen areas

Maintain high standards of hygiene by adhering to company policies & procedures

Seek to provide healthy options and to promote healthy eating within the school environment, acting as a role model for students

Encourage students to contribute to cleaning up; place plates and cups in the dishwasher, leaving the lunchroom in a safe and clean environment.

Check fridges in both kitchens regularly and dispose of any out of date food safely

Clearly label all food once it has been opened/defrosted

Purchase supplies and foodstuffs from local shops as required

Over time, be willing and able to support student learning in the kitchen area and to supervise their participation in meal preparation.

Any other such duties as may be required commensurate with the scope and nature of the post

This role profile is not exhaustive and is subject to review in conjunction with the post holder and according to future changes/developments in the service.

**Contacts:** The post holder will work closely with the Business Manager, Leadership team, staff and support staff within the school. The role will likely involve contact with parents, carers and visiting professional staff such as Educational Psychologists or Social Workers, as well as School Governors.

**Supervision:** The post holder will report directly to the Business Manager
